I understand that should it be reasonably determined that I or those I have shared this information with have breached this Agreement that I/we may be legally and/or financially responsible for costs incurred by or to this business associated with that action.		
I pledge that I (or any related person or corporate entity) will not visit or contact the principals, employees, shareholders, suppliers, bankers, landlords, etc. of the above business at any time, without written permission from the Broker. I understand that there may be negative consequences and possible legal implications should this pledge be breached. I acknowledge that any information given to me by the Broker is solely for the purpose of evaluating that business as a potential purchaser. Further, I acknowledge that I am not an agent of or connected in any fashion to any local, provincial, or federal government agency, or any other third party with any possible interest of the business other than for the possible future purchase of the business. I acknowledge that the Broker cannot make any representation or warranty as to the accuracy or completeness of any information provided and that the information is provided in good faith only.		
I, the undersigned, am aware of the asking price of this business and I (or any related party or corporate entity) have (or reasonably believe to have) access to the financial capital to enter into a purchase agreement should it be deemed appropriate to proceed with an Offer to Purchase.
